Hey Damon,

Your mom tried to stop the hearing on Thursday by filing a recusal motion [see [Statement of Disqualification](#)] because Judge Alksne said she was not going to let you testify about the abuse, which of course is what explains and counteracts the accusations against your mom of "alienating". But Alksne would only let in testimony which would work against you and it was obviously another ploy to get you back, take you away from your mom and force you to live with Eric full time again.

Judge Alksne held the hearing illegally anyway without your mom and made orders to send your case to the Child Abduction Unit. Isn't that funny: boy runs away from abusive father, asking the judge to be able to live with mom and judge calls it "abduction". Too bad she could not do what's best for you for once. Cindy is still trying to get her off the case and get an unbiased judge.

Sorry to say Evan and Cheryl Korman testified against you and Ryan wouldn't even write a declaration supporting you. Don't feel too bad though. Eric and Nicole have them completely under their thumbs with all the bribing and brainwashing. Ryan wants to go to an expensive private college and he knows if he helps you, that won't happen.

Financial dependence is main weapon of abusers' and is a type of torture---holding such huge carrots out for vulnerable, traumatized teens who have to choose between the bribe and doing what is right. Eric and Nicole are disgusting for using intimidation and bribes to control your brothers and keep them away from their mom. Shame on them. Only monsters take children away from their mother.

Thank god they have not broken your spirit yet, but they will do their best if they get you back and it won't be nice. Now that they know that their punishments, bribing, and psychological coercion by well paid psychologists don't work on such a strong, smart kid like you, the only method left is sending you to a camp where they combine psychological coercion with drugs, electroshock "therapy" and physical torture. Kids are never the same after returning from those camps. Check out the book, "Help at Any Cost" by Maia Szalavitz. It shows some of the torture they subject kids to in order to break them and make them submissive to their parent's control. And Abusers know exactly which camps will also get you to recant sexual abuse by fathers (for extra \$\$).

And if you come back, they will probably never let you see your mom again, since they are as usual blaming her for you running away. Judge Alksne made a no contact order between you. She is once again using your relationship to punish you instead of listening to what you want and need. They may put your mom in jail to try to intimidate her and you.

Don't worry about that and do not come back even if they do. She does not mind being in jail to keep you safe. Besides it will probably bring media attention that could help you.

Anyway, jail and camps are just the predictable next steps in Gardner's "Parental Alienation" methodology of silencing women and children about abuse. Don't let them scare you. Keep fighting for your right to be safe and live with your mom. And whatever you do, stay safe wherever you may find yourself.

**Damon's Story**

After two years of trying unsuccessfully to protect Damon in San Diego Family Court under Judge Michael Smyth, Damon's mom, Cindy Dumas, took his brothers and him into hiding.

**After three years in hiding, D.A. Bonnie Dumanis conducted a review of old documents and found there was enough evidence of sexual abuse to dismiss all abduction charges against Cindy.**

Deputy D.A. Teresa Santana said she believed Damon, but did not think there was not enough evidence for "beyond a reasonable doubt" (without having conducted interviews with Damon or any other witnesses), so they could not prosecute the father.

D.A. Dumanis had promised if they came back to San Diego there would finally be a proper investigation and fair hearing, and Damon would be listened to and protected from his father, **Eric Moelter**, whom he says sexually and physically abused him for many years and threatened to kill him if he told anyone.

**But D.A. Dumanis gave the case to Family Court Judge Lorna Alksne McKellar, who deliberately violated the laws which were specifically enacted to protect children like Damon.**

Judge Alksne did not do the minimum required to investigate the abuse as per **Family Code 3118**; she denied his due process right to an evidentiary hearing and wouldn't allow him to testify; she suppressed critical evidence, including the video of Damon describing years of abuse to the Chadwick Center and the transcript of his in-chambers testimony, in violation of **Family Code 7892**; and she violated **Family Code 3027.5** which prohibits removing custody from protective parents.

**INSTEAD OF JUSTICE AND PROTECTION,**

**Judge Alksne used the bogus and inadmissible "Parental Alienation" (PA) theory to take Damon and his brothers away from their protective mom and place them with his abuser. PA theory was created by pedophile Richard Gardner as a disguised way of calling women and children who report sexual abuse liars, silencing them and enabling the switching of custody to the molesters.**

**Judge Alksne then appointed Dr. Breffni Barrett to "deprogram" the boys into recanting or "forgetting" about the abuse and submitting to living with the abuser.**

"Deprogramming" is pedophile Gardner's cure for PA, as he claims mothers program their children to report abuse.

But what Barrett and all the "Reunification" psychologists actually do is coerce the children to recant the abuse and convince them their mom's the one to blame.

This is what happened to Damon's brothers. But Damon was too smart and strong to fall for it.

When Damon could not be persuaded by Dr. Barrett into recanting the abuse, Alksne said she would cure his "psychological impairment" by sending him to a boarding school/camp outside of California *where they use torturous POW tactics to break the child's will.*

But Damon's mom protested publicly and Alksne dropped it--so far.

Eric filed a motion to send all the boys to a camp for "deprogramming".
