REASON FOR REFERRAL

The present custody evaluation is being conducted as a result of allegations made by Ms. Dumas against Mr. Moelter. These allegations strongly suggest that Mr. Moelter has acted inappropriately with his youngest child, and questions the nature of contact and whether or not there should be supervision on an ongoing basis.

The Moelters divorced several years ago and had apparently been successful in child sharing up until the current custody difficulties. Ms. Dumas has been the moving party regarding these issues and has been steadfast in her resolve to find Mr. Moelter responsible for molesting his son Damon.

The present evaluation involves all members of the family constellation, collateral contacts with additional individuals, and review of documentation.
